



Child Safeguarding Statement

SWICN Clubhouse is a youth project that runs programs for young people aged between 10 and 24 years, living within the South West Inner City area of Dublin. Our programmes are educational and developmental with a focus on technology and creativity. We provide group work and 1 to 1 work both on site and off site.

SWICN Youth Service has completed an assessment of the potential for harm to the young people that are engaged in this organisation and a Risk Register in relation to this. Harm in this context is related to assault, ill-treatment or neglect of the child or young person that seriously affects or is likely to seriously affect the child or young person's health, development, welfare or sexual abuse of the child or young person. This register identifies all risks of harm and lists the procedures, policies, programmes and practices that help reduce or eliminate these risks.

	Risk Identified*	Level of risk	Control in place
1	Risk of harm to a child by staff/ volunteers.	Medium	Staff/volunteers are vetted and have relevant up to date child safeguarding training. There are always 2 staff present with young people.
2	Risk of harm to a child from a service user (adult or child), visitor or member of the public.	Medium	Young people are supervised at all times. Members of the public are not permitted to be in care/supervision of young people. Internet use is supervised. Inappropriate sites are blocked.
3	Risk of harm to a child due to a child protection or welfare concern not being recognised or reported by a staff member.	Medium	Staff/volunteer check-ins are held after every program. Staff/volunteers are given a copy of the Child Safeguarding Statement. Staff/volunteers are trained to recognise and report child protection or welfare concerns. All concerns are brought to the attention of the Designated Liaison Person.
4	Risk of harm to a child due to a child protection or welfare concern not being recognised or reported by a child.	High	Young people are regularly reminded to raise issues & concerns with staff. Staff check in with young people regularly.
5	Risk of harm to a child from another Young Person	Medium	All spaces are facilitated by youth workers and young people are accompanied, when and where there is an area where a young person has to use a facility for the use of Toilet or changing room youth workers will be vigilant outside that facility and will listen and monitor the situation.

*All above risks include risk where youth work is done online or by phone


Our Child Safeguarding Statement has been developed in line with the requirements of the Children First Act 2015, Children First: National Guidance for the Protection and Welfare of Children 2017 and Tusla Child Safeguarding: A Guide for Policy, Procedure and Practice.
